**I understand the following:** (Please initial each box)

	<p>By signing this form, you are <u>temporarily</u> surrendering your animal to Sandi Paws Rescue, Inc (SPR) for the sole purpose of spay or neuter and any vaccinations needed. You agree that all medical paperwork will be in the name of the Rescue. You will agree to pay all fees associated with the spay or neuter of your pet. If there is anything medically necessary beyond a normal routine spay or neuter, you will be responsible for that additional fee. By signing this contract, you understand if anything happens during surgery or post operatively, you agree to not hold Sandi Paws Rescue, Inc, a 501c3 non-profit organization, OR Precision Veterinary Services, legally responsible for any incident that may occur. This is a onetime courtesy appointment which includes transportation and we are offering you an affordable option to have your pet spay or neutered. You also understand that Victoria Timreck, President of SPR will make all medical decisions should any event arise with your pet while in the care of Precision Veterinary.</p>
	<p>On Spay/Neuter days, SPR assumes we are transporting healthy cats or dogs with a normal anatomy to Precision Vet. If you have any concerns, this should be brought to our attention <u>5 days prior</u> to their appointment to avoid any additional risks.</p>
	<p>No advanced diagnostics will be performed prior to surgery. Some medical conditions, which may increase the patient's risk, may not be detected/detectable without such testing. You are solely responsible for informing SPR of any known preexisting conditions. SPR or Precision Veterinary is not responsible for any unknown complications that may happen associated with your cat/dog.</p>

	The surgery performed is considered a major surgery. Pregnant females or those in heat may be spayed but the risk to the animal <i>may be</i> increased. Every reasonable precaution and the best possible medical care will be exercised. This may include the decision not to perform surgery at SPR's or Precision Veterinary's discretion.
	All spay/neuter procedures are completed with a small green tattoo located on the stomach to indicate that the animal has been surgically altered. We require a left ear tip to be performed for all outdoor cats.
	In rare cases, male animals may have undescended testicle(s). This is called cryptorchidism and it can naturally occur in some animals. For these animals to be neutered, I understand that the veterinarian will need to perform additional surgical procedures and an additional cost will be incurred. This cost is generally \$20 more. The same goes for hernia repairs which are generally \$25.
	If live fleas are found on your pet, Cap Star flea killer will be used and a small charge (per pet) will be added. This is for their safety as well as the safety of other pets. The cost for this is generally \$5. If there is loose stool with an animal, Precision Veterinary Care reserves the right to dispense dewormer, which will increase the charge of the procedure generally no more than \$35.
	Any additional or outstanding amount due will be paid in full at the time of pick up unless other arrangements have been made with both the Spay/Neuter Coordinators. SPR reserves the right to not release your pet back into your care until the full payment has been made.
	You agree to properly care for the animal after surgery. This includes any follow-up care and medications post-surgery. You will follow the post-surgical care form provided at the time of pick up.
	You understand that if your pet does NOT receive surgery there is a \$50.00 charge for the physical exam (by a veterinarian), house, and transportation.

Consent form and waiver:

I request that Sandi Paws Rescue, Inc and/or Precision Veterinary Clinic provide services for my animal. I agree to waive any or all claims against Sandi Paws Rescue, Inc, SPR Waggin' Wheels, Inc, and Precision Veterinary Clinic, as well as the officers, coordinators, employees, and volunteers in the event of escape, injury, surgery complications, or death of my animal. I have read, understand and agree to follow all aftercare instructions provided by Precision Veterinary Clinic and/or my veterinary. I will seek the care of my veterinarian or contact SPR for any suspected post-surgical complications and bear full financial responsibility for any expenses incurred. I hereby declare under penalty of perjury that I am the owner (or authorized agent) of the above described animal(s), that I have read and agree to all above statements, and that I have not withheld any information regarding known pre-existing medical conditions.
